5 LOCAL 1948, THE ASOTIN-ANATONE CHAPTER AND THE ASOTIN-ANATONE SCHOOL  
6 DISTRICT #420. THIS AGREEMENT IS ENTERED INTO PURSUANT TO ARTICLE XVII,  
7 SECTION 17.1 OF THE CURRENT COLLECTIVE BARGAINING AGREEMENT.
